ASSUMPTION OF RISK:

I AM AWARE THAT THERE IS POTENTIAL RISK FOR INJURY INVOLVED IN WATER SPORTS, including canoeing. I freely accept and fully assume all such risks, dangers and hazards, including risk of personal injury, death or property loss resulting from my participation in canoeing and Dragon Boat racing.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT:

In consideration of approval to participate in the activity of canoeing and Dragonboat racing at Boulevard Lake or other sites, I hereby agree as follows:

1. To waive any and all legal claims that I have or may in the future have against Lakehead Canoe Club, its directors, officers, employees or agents, representatives or any person in any way connected with Lakehead Canoe Club (all of whom are hereinafter collectively referred to as "the releasees"); to release the releasees from any and all liability for any loss, damage, injury or expense I may suffer, or that my next of kin may suffer as a result of my participation in the sport of canoeing and Dragonboat racing at Boulevard Lake or other sites, due to any cause whatsoever including negligence, breach of contract, or breach of the statutory or other duty of care. I acknowledge my responsibility to ensure adequate medical, personal health, dental and accidental insurance coverage, as well as protection of my personal possessions.
